With the enhancements to CHAS, all Singapore Citizens can now receive **subsidies for chronic conditions** at participating GP clinics.

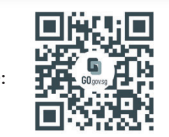

## About CHAS

The Community Health Assist Scheme (CHAS) enables Singapore Citizens to receive healthcare subsidies for medical and dental care at participating General Practitioner (GP) and dental clinics near their home.



CHAS, Merdeka Generation and Pioneer Generation cardholders can enjoy subsidies at CHAS clinics by showing their CHAS card, Merdeka Generation card or Pioneer Generation card with their NRIC during visit.



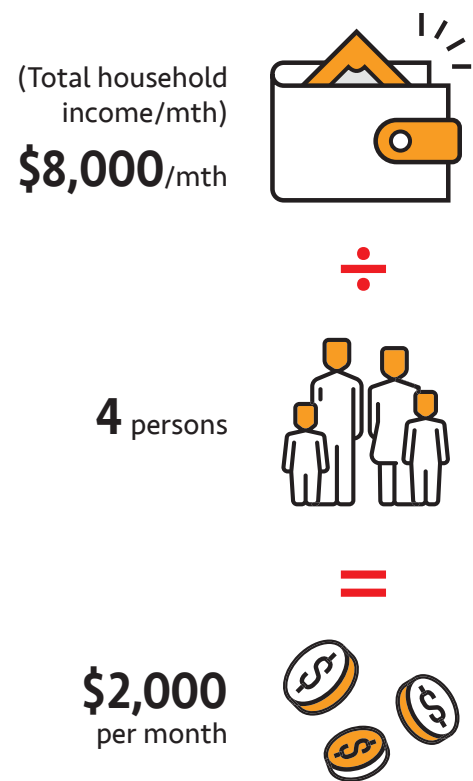
Cardholders below 15 years old will need to present their CHAS card and birth certificate/student ID.

CHAS clinics can be easily identified by the CHAS sticker displayed.

## How is household monthly income per person calculated?

Total gross household monthly income\* divided by total number of family members living together\*\*.

For example:



\* Gross monthly income refers to basic income, overtime pay, allowances, cash awards, commissions & bonuses.

\*\* Only family members who share the same NRIC address and are related by blood, marriage or legal adoption are included in this calculation.



## CHAS Criteria

All Singapore Citizens are eligible for CHAS. Benefits will be tiered according to:

- Household monthly income per person (for households with income); or
- Annual Value (AV)<sup>1</sup> of home (for households with no income).

## How to Apply?

Visit [www.chas.sg](http://www.chas.sg) and submit an online application for your household. Alternatively, you can pick up a CHAS application form at any Community Centre or Club (CC), Community Development Council (CDC), Public Hospital or Polyclinic.

Only one application per household is needed. Eligible family members in your household will receive a CHAS card.

<sup>1</sup> The AV of your home is the estimated annual rent if it is rented out. It is assessed by IRAS.
